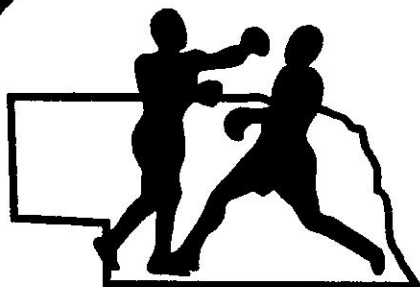

Therefore, we are implementing a new program which allows our coaches/mentors to become more involved in this process. The Omaha Public Schools is preparing a letter for the mentors/coaches of B&B Boxing Academy to work along with you as the child's parent/guardian to help increase your child's academic success this year. This letter would have been completed and signed by you in order to give us your consent to engage in this process. Our coaches/mentors would be given access to your child's portal in order to keep up with their day to day progress. They would also be given consent by this letter to call or visit the schools, attend conferences, etc. Again, this would all have to be done with your consent, approval, and involvement. We are not attempting to replace you as the parent/guardian in this process, but instead would like to work side by side with you to ensure our children are getting the very best education possible. PARENTAL INDEMNIFICATION**

IN CONSIDERATION OF ME BEING ALLOWED TO PARTICIPATE IN ANY WAY IN ANY OF THE B&B SPORTS ACADEMY, INC., aka B&B BOXING ACADEMY ACTIVITIES at 3034 Sprague St., Omaha, NE, I AGREE:

1. I understand the nature of The B&B Boxing Academy activities and my experience and capabilities and believe I am qualified to participate in such activity. I further acknowledge that I am aware the activity will be conducted in facilities open to public during the activity. I further agree and warrant that if I believe conditions to be unsafe, I will immediately discontinue further participation in the activity.
2. **I FULLY UNDERSTAND** that (a) The B&B Boxing Academy activities involve risks and dangers of SERIOUSLY BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH (ARisks@); (b) these Risks and dangers may be caused by me or the actions or inactions of others participating in the activity, the condition in which the activity takes place, or THE NEGLIGENCE OF THE RELEASEES NAMED BELOW; (c) there may be other risks and social and economic losses either known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES incurred as a result of my participation in these activities.
